ELECTION NOTICE - E2024/17 - Stage 1

Scheduled Election

Fair Work (Registered Organisations) Act 2009

Nominations are called for:

CPSU, the Community and Public Sector Union - SPSF Group
- Federal Secretary (1)

Nominations, which must be in writing and comply with the registered rules of the Organisation, may be made at any time from 11/08/2025. Additional forms are available from the Returning Officer.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 12:00pm Australian Eastern Standard Time (AEST) **on** 25/08/2025.

How to lodge nominations, nominations must be lodged via the following method(s):

By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to IEBnominations@aec.gov.au.

The subject line of your email should include: "E2024/17 Stage 1 – CPSU SPSF Group - Your Name".

PLEASE NOTE:

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
3. You may call 03 9285 7111 to enquire about the status of your nomination.

Closure of Roll of Voters

The roll of voters closed on 4 August 2025, which was seven days before the date nominations opened.

Withdrawal of Nominations

Candidates may withdraw their nomination no later than 12:00 noon (Australian Eastern Standard Time (AEST)) on 25/08/2025. As per Rule 23.1, candidates may withdraw their nomination, and the notification must be in writing must include the signed endorsement of the nominee.

Candidate Statements

Candidates may submit a statement not exceeding 200 words to be included with ballot material. Only statements which comply with the rules and are received by the Returning Officer by 12:00 noon (Australian Eastern Standard Time (AEST)) on 01/09/2025 can be accepted.

Voting Period

The postal ballot, if required, will open on 15/09/2025 and close at 10:00am (Australian Eastern Daylight Time (AEDT)) on 13/10/2025.

Replacement Voter Pack

If the postal vote pack is not received by 29/09/2025 voters may contact the AEC to request a replacement voter pack by calling 02 9375 6366 or 03 9285 7111 or by sending an email to IEBEvents@aec.gov.au.

Scrutineer Appointment

The appointment of scrutineers closes at 10:00am (Australian Eastern Daylight Time (AEDT)) on 13/10/2025. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
